Recently I sent an update the AMAs and ADs. Below are important parts of the update. I believe that this is a very important topic that needs to be discussed and decisions made soon, if not immediately.

*"Last year the Section 10 Area Directors decided that the seven required board positions in each region will be filled, trained, and certified in order to be eligible to participate in the Section 10 Invitational Playoffs.*

*There is a very strong push from the National Board, the Section Directors, and Section 10 Area Directors to get this training to the board members. Experience shows us that Regions that have the trained and certified board members are less likely to have problems and their programs run much smoother.*

*The RC appointment forms include the agreement that the RC will ensure that the positions are filled and properly trained. All of you are at various stages of filling the seven positions on the regional boards, evaluating your training needs, and setting training dates. Let's help them get the training completed."*
